


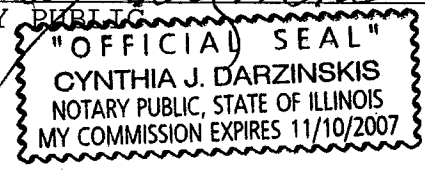
OATH OF OFFICE

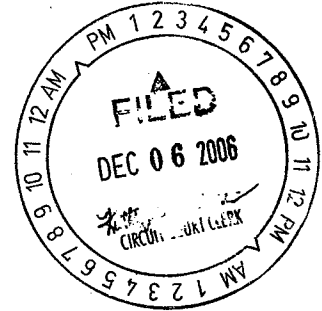





BOND OF COMMISSIONER


